BOARDING AGREEMENT
TERMS AND CONDITIONS
March 1st 2008

INSURANCE: It is the responsibility of the owner to carry minimum liability coverage of \$1,000,000.00 on any horse boarded at Crystalbrooke Farm. The owner must provide details with the name of their insurance company upon entering into this agreement and yearly thereafter.

EMERGENCY CARE: The owner gives permission for Crystalbrooke Farm to act on an Emergency basis for the health and well being of their horse. The owner agrees to pay for all medical treatment and professional fees.

VETERINARY AND FARRIER SERVICES: It is the responsibility of the owner to ensure that their horses are in a good and healthy condition at all times. Regular services for health, foot and parasite control is provided. All extra fees relating to these services shall be paid for by the owner directly to the Vet/Farrier at time of service or upon receipt of an invoice. **A \$5.00 handling charge** will be added to fees paid by Crystalbrooke Farm. To help minimize the cost of annual vaccinations and worming medicine, owners will be invoiced for these services only, at month-end.

PART BOARD/LEASE: Arrangements between owners and a third party are subject to this agreement. Owners shall be responsible for ensuring that any persons involved are aware of the conditions and rules of this establishment. Upon instruction third parties will be invoiced separately as a courtesy only as this agreement is between the owner and Crystalbrooke Farm.

DEFAULT: Non-payment of board shall be dealt with by Crystalbrooke Farm under guidelines of the KEEPERS ACT, RSO 1980 c217.
N. S.F. cheques will have a \$25.00 handling charge applied.

RULES AND REGULATIONS: The owner must agree to abide by the Barn and Safety Rules and the Terms and Conditions of this agreement. Failure to do so will result in the immediate termination of this agreement.

Notice of 1 calendar month must be given to terminate this agreement.

BARN HOURS:

9 A.M. - 9.00 P.M. Monday to Friday/ 9 A.M. - 6.00 P.M. Saturday and Sunday

The terms and conditions of this agreement are subject to change on January 1st 2009.

BOARD

Daily ~ \$20/day Monthly ~ \$525.00

Basic Board ~ \$675/month 4 lessons taken within the month. (1 hour group or 1/2 hour private)
~ \$775/month 8 lessons taken within the month. (1 hour group or 1/2 hour private)

Lessons are to be taken within the month paid. Any adjustments for cancelled or make-up lessons carried over to the next month will not be subject to the discounted rate.

- Daily turnout, weather permitting.
- Daily clean-out.
- Individual feeding program.
- Initial care of minor injuries.
- Arranging of regular hoof and health care.
- Administration of worming program (excluding cost of medication).
- Use of outdoor and indoor arenas at designated times.
- Use of non-fenced land for hacking.

Training Board ~ \$250/1week - \$450/2weeks - \$875/month

~ \$970/month - 1st month only. Backing and starting unbroken horses.

- Lessons or training (4 x per week).
- Applying and removing blankets, boots & bandages.
- Trimming.

Show Board ~ \$1200/month

- Everything in Basic Board.
- Lessons or training (6 x per week).
- Day care and riding/showing fees are included.
- Trimming and body clipping.

LESSONS & TRAINING

- Individually booked or adjustments of pre-paid lessons - 1/2 hr private or 1 hour group ~ **\$40.00**
- Individually booked 1 hour private ~ **\$55.00**
- Training sessions - horse only ~ **\$40.00**
- * The above rates apply to boarders only.

SHOWING

- Coaching all show levels ~ **\$50.00 per day.**
- Showing per class ~ **\$25.00**
- Day care at all away shows ~ **\$35.00 per day.**
- Braiding ~ **\$35.00 mane only.**
- **Costs for set-up items, Camper site and expenses at away shows will be split equally among competing horses.**

OTHER FEES

- Body Clipping ~ **\$135**
- Trimming ~ **\$25.00**

All purchases/sales and consultations (horses & equipment) are subject to a minimum 10% agents/ commission fee plus expenses .

All of the above rates are subject to G. S. T. and are non-refundable.

Board rates are for a calendar month, horses arriving mid month will be charged the daily rate or the full month, whichever is less.
